





GENERAL GUIDELINES FULL PAPER

for the 6. Culinary Wine Tourism Conference Krems 2024

- **1.** All papers must be prepared in English and free of grammatical, spelling and/or punctuation errors. Please make sure your paper is thoroughly proofread before submission.
- **2**. **Length of the final paper:** between 20.000 and 25.000 characters incl. blanks, incl. references.
- **3.** Papers submitted should be original contributions not published before. In order to insure academic integrity, submitted papers may be randomly scanned by plagiarism detection software.
- **4. Body:** body text: font "Arial", 10 pts.; major headings font "Arial", 16 pts., in bold, subheadings font "Arial", 12 pts. In bold. All text should be single-spaced. All headings flush with the left margin. Add three empty lines (font size: 10 pts) before the first line of text. Leave two empty lines (font size: 10 pts) between major heading and subheading.
- **5. Tables and Figures:** Tables and figures should be numbered sequentially in numerals e.g. Table 1, Table 2, Table 3, etc., and should bear a caption which explains their contents, as well as a reference, if applicable, e.g. "fig. 1.1 cultural production, cited from Bourdieu (1999), p. 203". Add a cross-reference for each table in your text: instead of writing "the following table shows..." cite "fig. 1.1 shows".







- **6. Images:** It is recommended that you use TIFF files for producing images or photographs, and EPS files for vector graphics (illustrations). MS Office files are possible, too. All images including photographs must be stored in a separate document. As file name please use "fig." and the sequential number, e.g. "fig1.1.eps". Images for printing should always have at least a resolution of 300 dpi at the size in which they are going to be printed. Entitle your images in the same way that you entitled your tables. e.g. Table 1, Table 2, etc. Add a cross-reference for each image in your text. Instead of writing "the following images show..." cite "fig. 1.1 show". Images in colour will be printed black-and-white. Don't refer to colours in your text. For captions or titles please use font "Arial", 8-10 pts. Please add captions or titles only in your paper, not in the separate images document.
- **7. Citation:** within the body text please cite as follows: author(s) and year of publication in round brackets:

....Bourdieu (1990) .....author mentioned within the text,
```

otherwise (Bourdieu 1990, S. 120)

or (Weber 1956, S. 20ff.; Durkheim 1988a, S. 41f.)

or (Giddens 1984b, 1990; Parsons 1969)

Two authors: (Münch und Smelser 1992, S. 11)

more than two authors: (Zapf et al. 1990)

- **8. References:** please add references in chronological order at the end of your paper; please use the following abbreviations:
- vol. (volume)
- Aufl (Auflage)
- ed. (editor)
- p. (page)
- **9. Citation style:** please use the "SozPsych", a citation style following the requirements of APA (but in a more simple version) as follows:

Instead of "and" please use "&"; use italic letters (no abbreviations) for journal and book titles.
